SUPPLY CHAIN / LOGISTICS START-UP

Recognizing startups who are making an impact in the sector by bringing new products/ technologies/ business ideas in the industry.

Criteria

- ❖ **Problem Solving:** The start-up should address critical challenges or pain points within the supply chain logistics ecosystem. They should have developed solutions that effectively solve industry-specific problems, streamline operations, or create new opportunities for collaboration and optimization
- ❖ **Innovation and Disruption:** The start-up should demonstrate a high level of innovation and disruption within the supply chain & logistics industry. This can include introducing new technologies, business models, or processes that significantly improve efficiency, reduce costs, or enhance customer experiences.
- ❖ **Market Potential:** The start-up should demonstrate a strong market potential and a clear value proposition. Their offering should have the capacity to scale and address a sizable market segment within the supply chain & logistics industry. Factors such as market demand, growth potential, and competitive advantage will be the driving factors.
- ❖ **Execution and Traction:** The start-up should have demonstrated strong execution capabilities and achieved notable traction in the market. This can include factors such as customer acquisition, revenue growth, successful pilot implementations, partnerships or collaborations with established players, or measurable impact on the industry.
- ❖ **Team and Leadership:** The quality and expertise of the start-up's team and leadership are crucial considerations. Their vision, strategic thinking, and ability to execute will be the key.
- ❖ **Sustainability and Scalability:** The start-up's business model and solutions should demonstrate long-term sustainability and scalability. Factors such as the potential for profitability, scalability of operations, adaptability to changing market conditions, and alignment with industry trends should be assessed.
- ❖ **Customer Impact:** The start-up's solutions should have a positive impact on customers and end-users. This can include improved efficiency, cost savings, enhanced visibility and transparency, better customer experiences, or reduced environmental footprint. Customer testimonials or case studies can provide insights into the start-up's ability to deliver value to their target audience.

INDIVIDUAL LEADERSHIP AWARDS

SUPPLY CHAIN/LOGISTICS LIFETIME ACHIEVEMENT AWARD

Recognize business leader who had a significant impact on their organization and on the SCM industry fostering innovation. Individual must have more than 20 years of experience in the SCM industry including 3 years of experience as Chief Executive or equivalent of the current organization.

Criteria

- ❖ **Industry Contribution:** The individual should have made significant and lasting contributions to the field of supply chain management. This can include innovations, breakthroughs, or influential ideas that have had a profound impact on the industry.
- ❖ **Leadership:** The recipient should have demonstrated exceptional leadership qualities and have played a pivotal role in driving positive change within the supply chain domain. This can include leading successful supply chain transformations, guiding organizations through challenging times, or fostering collaboration and cooperation within the industry.
- ❖ **Career Accomplishments:** The individual's career accomplishments should reflect a consistent track record of excellence in supply chain management. This can include achievements such as optimizing supply chain operations, implementing effective strategies, achieving cost savings, improving customer satisfaction, or driving sustainable practices.
- ❖ **Industry Recognition:** The recipient should be widely recognized and respected within the supply chain community. This can include receiving awards or accolades, holding leadership positions in industry associations or professional organizations, or being regarded as an influential thought leader through publications, speaking engagements, or industry contributions.
- ❖ **Mentorship and Legacy:** The individual should have contributed to the development of future supply chain professionals through mentorship, knowledge sharing, or educational initiatives. They should have acted as an advocate for responsible supply chain operations and have made a positive difference in the broader societal context.
- ❖ **Enduring Impact:** The individual's contributions should have a lasting impact on the supply chain industry, transcending specific companies or periods of time. The award recipient should have influenced and shaped the field of supply chain management in a way that continues to be relevant and impactful today.

SUPPLY CHAIN / LOGISTICS TRAIL BLAZER OF THE YEAR AWARD

Recognize business leader who had a significant impact on their organization and the SCM logistic industry fostering innovation, process improvement and effectiveness. Individual must have shown such initiative and work for more than 3 consecutive years

Criteria

- ❖ **Innovation and Thought Leadership:** The individual should have demonstrated a forward-thinking approach and introduced innovative ideas, strategies, or technologies that have had a transformative impact on the supply chain and logistics industry. Their contributions should have pushed the boundaries of traditional practices and inspired others in the field.
- ❖ **Industry Influence and Advocacy:** The awardee should have a strong presence and influence within the supply chain and logistics community. They may have actively participated in industry associations, conferences, or forums, advocating for advancements, sharing knowledge, and driving conversations that shape the future of the industry.
- ❖ **Performance and Achievements:** The individual's track record should showcase exceptional performance and achievements in the supply chain and logistics domain. This can include accomplishments such as improving operational efficiency, implementing successful supply chain strategies, driving cost savings, achieving measurable results, or leading successful transformations.
- ❖ **Change Management and Adaptability:** The awardee should have demonstrated effective change management skills and the ability to adapt to evolving business landscapes. They may have successfully navigated disruptions, implemented agile practices, or proactively embraced emerging technologies and trends to stay ahead of the curve.

SUPPLY CHAIN/ LOGISTICS YOUNG GUN OF THE YEAR AWARD

A relatively new entrant in the industry with minimum 2 years of experience but having age not more than 30 years as on 31st March 2023 and who has created massive impact on the supply chain & /or logistics industry with his/her leadership

Criteria

- ❖ **Early Career Accomplishments:** The individual should have achieved notable accomplishments early in their career in the supply chain and logistics industry. This can include specific projects, initiatives, or achievements that have had a significant impact on their organization or the industry as a whole.
- ❖ **Leadership Potential:** The awardee should demonstrate strong leadership qualities and exhibit the potential to become a future leader in the supply chain and logistics domain. This can include ability to inspire and motivate teams, take initiative, make informed decisions, and drive positive change within the organization.
- ❖ **Innovation and Creativity:** The individual should have shown a propensity for innovative thinking and creative problem-solving with the supply chain and logistics context. Their contributions may involve introducing novel ideas, approaches, or technologies that have improved processes, optimized operations, or addressed industry challenges in a unique and effective way.
- ❖ **Adaptability and Agility:** The individual should have demonstrated the ability to adapt to changing circumstances and navigate dynamic business environments. They should showcase agility in responding to disruptions, embracing new technologies, and adopting best practices to ensure the resilience and competitiveness of their supply chain operations.
- ❖ **Industry Engagement:** The individual should have actively engaged with the supply chain and logistics community, demonstrating a commitment to continuous learning and professional development. The involvement may include participation in industry events, forums, or associations, as well as knowledge-sharing activities such as speaking engagements, publications, or contributions to industry publications.
- ❖ **Collaboration and Relationship Building:** The individual should have a track record of successfully collaborating with internal and external stakeholders, fostering strong relationships, and driving collaborative efforts within the supply chain ecosystem. Their ability to work effectively with cross-functional teams, suppliers, customers, and partners should be considered.
- ❖ **Impact on Sustainability and Social Responsibility:** Consideration can be given to the individual's contributions to sustainability and social responsibility within the supply chain and logistics field. This can include initiatives or projects that promote ethical practices, environmental stewardship, social inclusivity, or community engagement.
- ❖ **Future Potential and Growth:** The awardee should demonstrate a high potential for future growth and advancement within the supply chain and logistics industry. Their passion, ambition, and commitment to personal and professional development should be evident, with a clear trajectory for continued success and leadership in their career.
